IGNORING SOFTWARE MODERNISATION CAN BE COSTLY

Software modernisation isn't sexy or fun. There, we said it!

While IBM applications are often mission-critical to business success, and much effort is invested in finding and implementing the best solutions, keeping existing software up to date often isn't a top priority. With other projects regularly perceived as more valuable and exciting, resources and budgets are allocated to them instead of software modernisation.

However, while this is a common and understandable approach, it is one that many IBM customers could come to regret.

When applications have been in use for a while, it is common for the customer entitlements (as per the license agreement) and the actual usage to no longer align. This can have severe consequences when the organisation uses more licenses or features than it purchased.

When IBM comes knocking for an audit, compliance suddenly becomes a priority – but it's often too late for an efficient, cost-effective review and modernisation project. If an organisation is found to be non-compliant, the penalties can be significant, but it is so much more than just a compliance issue.

Modernisation efforts – like a regular Software License Value Assessment – identify unused licenses, or product functionality which isn't being used, leading to significant cost savings. An assessment by an experienced team is an opportunity to check if the existing applications and technology landscape are still fit for purpose and can highlight opportunities for optimisation.

In other words, while software modernisation might not be sexy, it's not something you want to neglect – and the time to act is now. Out-of-date systems can cost your business by slowing you down, and you risk being left behind by your competition. In addition, once older systems have been ignored for a while, updating them becomes a bigger undertaking – which can seem daunting and unachievable.

The good news is that software modernisation can be done in a way that doesn't disrupt your business and allows you to reap the benefits without huge investments.



MODERNISATION OPTIONS

With the importance and benefits of software modernisation obvious, the question becomes “how?” How should IBM customers approach software modernisation? Generally speaking, there are three options



THE BAND-AID: MOVE TO THE CLOUD

One common approach to software modernisation is moving to the cloud. While this can be the right move in some situations, it’s no magic bullet. Unless addressed separately, many issues associated with legacy software and license misalignment will simply move to the cloud with you.



THE FULL TRANSPLANT: REPLACE EVERYTHING

Another approach to modernisation is to replace the entire system. While this would address many of the issues caused by legacy software and non-compliance, it is costly and can take years. It is also a very disruptive approach, which is simply not suitable for many organisations.



THE TREATMENT PLAN: CONTINUOUS MODERNISATION

It’s obvious that option one isn’t always suitable and option two is expensive and time-consuming. Many organisations stop here, deciding that software modernisation is not feasible, and delay any plan. However, there is a third option, one that takes a holistic approach to identify critical issues and opportunities to address first, while also developing a roadmap for ongoing modernisation, to ensure software applications stay up to date and add maximum value.
